Responsibilities: The Program Analyst is a dynamic position that will be an integral part of a small staff team who implements projects that help the Catalyst meet its mission. The Program Analyst, under the supervision of the Program Manager and the Director of Strategic Initiatives, provides counseling, guidance, and technical assistance to providers of Short Term Residential Therapeutic Programs (STRTPs), Foster Family Agencies (FFAs), and others. The Catalyst Center's provider helpline program is a part of the body of statewide supports offered through the organization.

Duties:

- **Program Service Delivery**

- ✓ Review and analyze relevant state-level letters and guidance that inform care standards for Foster Family Agencies and Short-Term Residential Therapeutic Programs, including communications published by the California Department of Social Services, and other relevant guidance from Department of Health Care Services, California Department of Education, and Department of Developmental Services including but not limited to Provider Information Notices (PINs) and All County Letters (ACLs);
- ✓ Respond to helpline inquires via telephonic and email methods, providing technical assistance, expert guidance, and providing warm handoffs to other resources as deemed appropriate;

- ✓ Continue to build upon and maintain the existing resource database around legislative, regulatory, and community-based information that impacts FFA and STRTP providers;
 - ✓ Support FFAs and STRTPs to creatively address and overcome permanency barriers and avoid placement disruption;
 - ✓ Respond to CDSS initiated requests for technical assistance and provider engagement;
 - ✓ Support STRTP and Residential Care providers to address AWOL/flight related behavior challenges and re-entry to programming, with a focus on consistency and stability;
 - ✓ Support providers and their partners to ensure children are accessing effective mental health and educational supports during this time that are in line with permanency goals;
 - ✓ Attend program meetings, events, and functions as required;
 - ✓ Participate in capacity building activities to support trauma-informed delivery of services and deepen understanding of current regulatory frameworks for care in these fields;
 - ✓ Provide trauma-informed counseling, support, and referral, referring up to supervisor and/or expert consultants when appropriate; and
 - ✓ Document call content and relevant interventions as appropriate.

 - ✓ Attend staff meetings, as assigned;
 - ✓ Other duties as assigned

Qualifications:

- **Required Qualifications**
 - ✓ Bachelor of Arts/Bachelor of Science degree or equivalent amount of years in experience. Advanced degree preferred;
 - ✓ Experience as a staff or management position in an STRTP or FFA, or comparable experience;
 - ✓ High level of organization, attention to detail, and ability to manage multiple projects concurrently;
 - ✓ Strong ability to take personal initiative, work both independently and as a team member, collaborate and coordinate with others;
 - ✓ Technical fluency in MS Office (including Outlook, Word, Excel and PowerPoint) and technical comfort with virtual platforms such as Zoom;
 - ✓ Ability to anticipate needs, exercise good judgment and thinking critically to proactively problem-solve in a fast-paced environment with minimal supervision;
 - ✓ Ability to adapt to dynamic environments; comfort with ambiguity and complexity;
 - ✓ Values listening to and honoring the wisdom of people on-the-ground and developing theory grounded in their lived experience;
 - ✓ Ability to give and receive constructive feedback; display a desire for continuous learning and self-improvement;
 - ✓ Personable and engaging, responsive to constituent inquiries and concerns; and
 - ✓ Excellent writing and communications skills with demonstrated experience conveying key messages clearly, timely and succinctly.
